CONDITIONS OF ENTRY

Nominations for all greyhounds (including exempted runners) must be received by Greyhound Racing Victoria (GRV) no later than 10:30am on **Wednesday, 19 November 2025**.

Nominations may be submitted to Greyhound Racing Victoria via FastTrack or by phone on (03) 8329 1100. The nominator must clearly advise **Greyhound Racing Victoria** that their nomination is for the Melbourne Cup.

Nominations can take place via FastTrack two weeks prior to the heats.

INTERSTATE ENTRIES PLEASENOTE: GRV recommends that all interstate greyhounds that are racing in Victoria for the first time are nominated early. This is to ensure that there is enough time to validate trainer and owner details prior to the close of nominations.

The greyhounds that win the following races **OR** compete in the SHOOTOUT at Sandown Park on Friday 14 November 2025 will gain exemption into the **Eight Heats** of the Melbourne Cup to be held on **Saturday 22 November 2025**, provided a nomination is submitted.

Any nominated greyhound that is not exempted under these conditions will **ONLY** be eligible for any remaining positions in the eight heats (plus reserves) by having competed (regardless of finishing position) in at least ONE Melbourne Cup Prelude Series during 2025. These remaining positions will be allocated based on the greyhounds ranking from lowest to highest.

Order of entry:

1. Exempt race winners
2. Prelude 2nd placed runners sorted by ranking
3. Remaining Prelude runners sorted by ranking

GRV Local Rule 50.2 Graders discretion shall also apply.

The 2025 Laurels Classic Final will be classified as being part of Series 3 of the Melbourne Cup Prelude Series. All greyhounds competing in the Laurels Final will be deemed to have competed in a set of preludes, with the winner exempt for The Melbourne Cup Heats.

Please be advised that the Cranbourne Cup Heats will be classified as Series 1 of the Melbourne Cup Prelude Series. All greyhounds competing in the Cranbourne Cup Heats will be deemed to have competed in a set of preludes with the winners exempt for the Melbourne Cup Heats.

Greyhounds may compete in any number of Preludes to enhance selection chances.

Composition of the heats will be subject to the top 25% of nominated greyhounds being seeded and distributed evenly amongst the heats, with the remaining 75% of greyhounds being drawn randomly into the heats. Guarding of owners and trainers in heats will apply where possible.

In the event of a dead heat in a Melbourne Cup heat GRV Local Rule 44.2 shall apply.

The connections agree to the use of their greyhound's name and photograph for promotional and/or advertising purposes by SGRC, or any firm, business or organisation approved by SGRC, arising from it competing in the 2025 Melbourne Cup series.

SGRC and GRV reserves the right to alter and/or add to these conditions. The final field for the 2025 Melbourne Cup final shall be determined in accordance with Greyhound Racing Victoria Rules and the Greyhounds Australasia Rules.
